MEETING DETAILS FOR LASSO 2006 IN LAREDO

Sponsored by Texas A&M International University and organized around the theme "Transcending Borders," the 35th annual meeting of the Linguistic Association of the Southwest will take place in Laredo, Texas, September 29-October 1, 2006.

The 2005 meeting will feature a plenary address by Ana Celia Zentella of the University of California San Diego. Dr. Zentella's topic is entitled "Transfronterizo Talk: Remapping the linguistic and cultural borders in Tijuana-San Diego." LASSO President Colleen Fitzgerald of Texas Tech University will address the topic of "Indigenous languages and Spanish in the U.S.: How can/do linguists serve communities?"

The conference will also host a number of outstanding papers, and panels, selected by the program committee chaired by Vice-President/President-Elect Kati Pletsch de García of Texas A&M International University. A preliminary program with further details appears inside this newsletter. Friday Sessions will be held on the Texas A&M International University campus; Saturday and Sunday sessions will be held at our conference hotel: La Posada.

REGISTRATION & FOOD

The PRE-registration fee for the 2006 conference will be \$125 for regular registration and \$95 for students. Onsite registration will be available at a cost of \$135 for regular

registration and \$105 for students. Please note that **the registration fee includes several meals.** A form for PRE-registration is included in this newsletter. **Attendees wishing to take advantage of reduced registration fees should complete their registration by September 22, 2006.** Payment may be completed by check or credit card following the directions on the form.

A registration table will be set up in the La Posada Hotel from 5 until 9 on Thursday night. The registration table will be available in during the day on Friday at the Western Hemispheric Trade Center Lobby and at the La Posada Hotel on Saturday.

Conference registrants will receive a packet containing the conference program and abstracts of presentations. Also included in the price of registration is the price for all meals. Registrants will be treated to 3 breakfasts, 2 lunches, 2 nice dinners and 5 conference breaks. What a deal!

LODGING

The conference hotel is La Posada Hotel/Suites located at 1000 Zaragoza St. in Laredo, TX. The phone number is 956-722-1701 (or 800-444-2099), and the fax number is 956-722-4758. The conference rate is \$85.00 for a single or a double and \$134.00 for a junior suite. **The cutoff date is currently September 14 for the LASSO rate.** Please call for reservations. **Be sure to identify**

yourself as being with the Linguistic Association of the Southwest to get the lower conference rate.

Mentioning your association with LASSO also ensures we get credit for the proper number of bookings that make that rate possible..

La Posada is located in historic downtown Laredo and overlooks the Rio Grande to Nuevo Laredo, México. Formerly a Spanish colonial convent, it is now a state-of-the-art meeting and banquet center. TRANSPORTATION

Laredo International Airport is served by several daily flights by American Eagle (1-800-433-7300), Continental Airlines (1-800-525-0280), and Allegiant Air (1-702-505-8888). The La Posada Hotel has a courtesy van that goes to and from the Laredo International Airport. It is a 10-15 minute drive to the hotel from the airport.

ALL ABOUT LAREDO

Laredo's unique location has played an important part in its history and economy. Founded in 1755, Laredo has seen 7 changes of sovereignty during its 250 year existence and flies seven flags in commemoration of its varied history: Spain, France, Mexico, Texas, Republic of the Río Grande, United States of America and Confederate States of America.

Now home to nearly 200,000 people, Laredo is one of the fastest growing cities in Texas. While in town, you may wish to take in a show at the Lamar Bruni Vergara Science Center, located on the Texas A&M International University campus, visit the Laredo Center for the Arts or travel to the various museums around town.

Laredo's sister city, Nuevo Laredo, is located just across the Río Grande and is home to nearly 360,000 residents. Connected over the years through historical, cultural, and linguistic ties, "Los dos Laredos" share a rich geographical and economic history.

Guerrero Street, heart of the Nuevo Laredo shopping district is within walking distance from the La Posada Hotel, just across the International Bridge #1, the recommended crossing point for visitors. There is a small toll charged to cross the bridge.

Most shops and restaurants will accept payment in US currency, and there are ATM machines available if you run low on cash. Each visitor is allowed to bring up to \$400.00 of merchandise for personal use every 30 days duty free. After that, a duty of 10% is levied. Please note that there are restrictions on the types of items you may bring back across the border. Read the signs as you cross or check with the officials to see what is and isn't allowed.

If you plan to spend some time in Nuevo Laredo, the Laredo Convention and Visitor's Bureau notes that U.S. citizens can stay within 26 miles of the border without a permit for up to 72 hours; however, they recommend that you carry proof

of citizenship, particularly if you are a naturalized U.S. citizen. If you are not a U.S. citizen, you need to confirm the status of your particular permit PRIOR to leaving the U.S. side of the border. Some general information can be found at the following website:

2005 ESAU AWARD WINNER

The Linguistic Association of the Southwest is proud to announce the winner of the 2005 Helmut Esau Award: **Naomi Fox**, of the University of Utah, for "Documenting Variation: Change in the person reference system on Walpole Island".

Ms. Fox presented data from fieldwork on Ottawa, a dialect of Ojibwa, which is an Algonquian language spoken in the northern U.S. and in Canada. Ottawa is an endangered language of the Americas, with this fieldwork focused on Walpole Island, Ontario. Fox's paper describes some grammatical implications of language death in this dialect, namely the restructuring of the person prefix system due to a phonological innovation. Three types of variation occur as a result of these interactions: retention, restructuring, and reduction. Congratulations Naomi Fox!

FUNDING AVAILABLE FOR COMMUNITY BASED RESEARCH PROJECTS
