### THANK YOU, UTB AND SOUTH PADRE ISLAND!

South Padre Island, Texas, was the site of the fabulous 40<sup>th</sup> Annual Meeting of the Linguistic Association of the Southwest. The meeting was hosted by the University of Texas, Brownsville, and held from September 30th to October 2nd, 2011 at the Pearl South Padre Hotel. Special thanks go out to John Foreman, the Local Arrangements Chair, and Holly Cashman, the LASSO Vice President and Program Chair. We would also like to thank all the faculty and student volunteers who contributed to the success of the conference, Daniel Villa for his continued help with PayPal, and UTB for its generous logistical and financial support.

The morning of Friday, September 30, featured parallel sessions on Language Rights, Attitudes and Policies, Subject and Object Pronoun Expression, Second Person Pronouns In Spanish, Language Contact, Heritage Spanish Lexicon, and Heritage Spanish Speakers' Attitudes. There was a Special Session on the editorship of *The Southwest Journal Of Linguistics* offered by the joint editors, Pamela Anderson-Mejías and Hugo A. Mejías. In the afternoon talks were presented on Language Ideologies, Historical Perspectives and Language Change, Migration, Revitalization and Demographic Factors, Pedagogy and Language Learning,

Variation in Spanish Morphosyntax, and Structures and Strategies of Spanish in Literature. Carmen Fought's plenary address, "Unchecking the boxes: The role of contact varieties in constructing identities" was an excellent fit for our conference theme of "English and Spanish in Contact".

Saturday, October 1, saw another full day of presentations. Special panels included "SWJL: How to get published 101", "Bilingual youth in Texas: Examining emergent social identities and linguistic practices", and "Spanish in Houston, *El español en Tejas—Más allá del 'Tex-Mex'*". There were parallel sessions on Linguistic Politeness, Mesoamerican linguistics, Variation in Spanish Phonetics and Phonology, Syntax, Semantics,

Discourse Analysis and Popular Culture, Transitivity and Ergativity, Language Maintenance and Shift, and Heritage Spanish Morphosyntax and Discourse. And we all learned from Irene Moyna's presidential address, "Linguistic research and why it matters: An example and some personal reflections", that *Google* indisputably ranks right up there with the invention of the wheel and penicillin. I'm sure many of us would agree.

Sunday's special panel on "*El español en Massachusetts: Historia, vigencia y actualidad*" and parallel sessions on Bilingual Proficiency and Assessment, Structure of Conversation and Performance, and Discourse Analysis, rounded out this year's offering of conference presentations.

**Thank you to all members who contributed news of their professional accomplishments for the current newsletter. Congratulations to all!**

**Eduardo D. Faingold** has a paper in press entitled "Official English in the constitutions and statutes of the 50 states in the United States", to appear in *Language Problems and Language Planning* in 2012. In his article Eduardo exhaustively screens the constitutions and legislative statutes of the 50 United States to identify legal language defining the linguistic obligations of the state and the language rights of individuals and groups. He suggests that in the United States, "hands-off" is good language policy not only nationwide but also statewide, because states adopting a hands-off linguistic policy are consistent with the Constitution of the United States, while states adopting a "hands-on" policy are in conflict with it. States adopting hands-on language legislation in their constitutions or statutes are deemed to be "nativist" because they seem unfavorable toward speakers of minority languages, while states adopting a hands-off policy are "non-nativist" because they seem favorable (or at least neutral) toward speakers of minority languages.

Eduardo is also proud to announce that he has been appointed to the board of trustees of the Sherwin Miller Museum of Jewish Art in Tulsa, Oklahoma. The Museum is dedicated to the collection and preservation of art and artifacts, and presentation of educational displays and programs, relating to the history of the Jewish people from its beginning to the present and around the world; the history of the settlement and contributions of Jews in the United States, in general, and in Oklahoma and the American Southwest, in particular; art by Jewish artists and artisans and about matters Jewish; the Holocaust and its lessons; and the history, life, culture and experience of Jews in the Land of Israel. The collections, displays and presentations shall be used in furtherance of the education of persons of all ages and cultures, from Oklahoma in particular, and all others who care to learn in order to foster understanding, cooperation and coexistence.

**Fredric Field** announces that he was promoted from Associate Professor to full Professor. In addition, his book, *Bilingualism in the U.S.A.: The Case of the Chicano-Latino Community* is now in print. According to the announcement from John Benjamins, the publisher:

This text provides an overview of bi- and multilingualism as a worldwide phenomenon. It features comprehensive discussions of many of the linguistic, social, political, and educational issues found in an increasingly multilingual nation and world. To this end, the book takes the Chicano-Latino community of Southern California, where Spanish-English bilingualism has over a century and a half of history, and presents a detailed case study, thereby situating the community in a much broader social context. Spanish is the second most-widely spoken language in the U.S. after English, yet, for the most part, its speakers form a language minority that essentially lacks the social, political, and educational support necessary to derive the many cognitive, socioeconomic, and educational benefits that proficient bilingualism can provide. The issues facing Spanish-English bilinguals in the Los Angeles area are relevant to nearly every bi- and multilingual community irrespective of nation, language, and/or ethnicity.

**María Irene Moyna** has recently published her book *Compound Words in Spanish: Theory and History* (Current Issues in Linguistic Theory 316, ISBN 978 90 272 4834 3). The publisher's website states:

This is the first book devoted entirely to the history of compound words in Spanish. Based on data obtained from Spanish dictionaries and databases of the past thousand years, it documents the evolution of the major compounding patterns of the language. It analyzes the structural, semantic, and orthographic features of each compound type, and also provides a description of its Latin antecedents, early attestations, and relative frequency and productivity over the centuries. The combination of qualitative and quantitative data shows that although most compound types have survived, they have undergone changes in word order and relative frequency. Moreover, the book shows that the evolution of compounding in Spanish may be accounted for by processes of language acquisition in children. This book, which includes all the data in chronological and alphabetical order, will be a valuable resource for morphologists, Romance linguists, and historical linguists more generally.

LASSO is very proud of all of our student members and encourages them to not only present their research at our annual meeting, but to also participate in the contest for the Esau Prize.

To be eligible for the Helmut Esau Prize, students must first present at the Annual Meeting and then submit a revised version of their paper to the LASSO Vice President. The prize is awarded to the best of all high-quality submissions received. Recipients of this prestigious prize receive a \$400 cash award.

If you are a student and presented your work at the LASSO conference on South Padre Island, you can be

considered for the 2011 Esau Prize. Your polished, article-length manuscript should be sent to Holly Cashman at ([holly.cashman@unh.edu](mailto:holly.cashman@unh.edu)) and must be in her hands by February 28, 2012.

This award is named in honor of Helmut Esau, who was active in the early days of LASSO.

Professor Esau died in an automobile accident shortly after he was elected to the LASSO presidency, and his colleagues at the time established the Esau Award to commemorate his contributions to the Linguistic Association of the Southwest and to the profession at large.

**ABSTRACT SUBMISSION GUIDELINES**  
**41ST ANNUAL MEETING OF THE LINGUISTIC ASSOCIATION OF THE SOUTHWEST**  
OCTOBER 11-13, 2012  
**DEADLINE FOR ABSTRACTS: MAY 25, 2012**

Conference Theme: Are language borders expanding, evolving, or eroding?

Abstracts for papers or posters in any area of linguistics are welcome, as are proposals dealing with language issues of special interest in the Southwest. Abstracts for papers or panels on border issues and language contact are especially welcome. Proposals for complete panels with 2-4 speakers are also welcome.

Submissions by graduate students are welcome, and students are eligible for the Helmut Esau Prize, which includes a \$400 cash award.

Deadline for abstract/proposal submission is May 25, 2012. Early submission of panel proposals is desirable.

Presentation format:

Presentation time for papers will be 20 minutes plus 10 minutes for discussion. Abstracts may be in English or Spanish. Presentations should be given in the same language as the abstract. Only one abstract as single author and a second as co-author will be accepted from any one individual.

Abstract format:

Abstracts should be 250-500 words, single-spaced in 12 point Times New Roman font. Abstracts should summarize the main points and indicate key aspects of the data and methodology. Use of special font items should be kept to a minimum. In general, omit the bibliography. Abstracts will be distributed via the Internet as received.

At the beginning of the abstract, write the title of the paper. At the end of the abstract, repeat the title and also list the author's name (if more than one author, list names in the order they should appear in the program), academic affiliation, mailing address, telephone number, and e-mail. If the author will not be available at his/her usual address or e-mail during the summer, provide summer contact information in the cover e-mail.

Abstract submission:

Abstracts should be e-mailed to [cleggj@ipfw.edu](mailto:cleggj@ipfw.edu) as a PDF or Microsoft Word (doc or docx). Special font items travel best as a PDF. In addition to sending the abstract as an attachment, please paste the text of the abstract into the e-mail message itself.

Authors will receive a reply notifying them that their abstracts are under consideration. If such notification has not been received within one week, the abstract did not reach its destination and should be resent. Authors will be notified by late July as to whether their papers have been accepted.

LASSO membership:

Participation in LASSO is a privilege of membership; this means that an individual must be a current member in order to present a paper and be listed in the conference program. You may fill out a membership form at the same time you register for the conference online. Membership includes a subscription to the Southwest Journal of Linguistics.

- Prepare manuscripts using WORD or another common word processing program for PC or Mac. Contact the editor for guidance in using special symbols.

- Submit manuscripts in either English or Spanish.
- Include an abstract in English of between 100 and 150 words.
- Submit 1 copy in WORD and one in pdf or hard copy for comparison (especially if symbols are used).

Given the comprehensive goal of the journal, attention is drawn particularly to the *Language* style sheet provision that contributors provide the names and addresses of appropriate referees.

The LASSO Executive Committee met Thursday night, September 29, 2011, at the Pearl South Padre hotel. The committee:

1. Approved the minutes of the 2010 Executive Committee Meeting in Las Cruces, NM.
2. Accepted Morin's financial report for the period of October 2010 through September 2011. The opening balance was 42,199.24. Income for the year was \$8,045.80, including \$159.15 in dividends, \$50.76 in royalties, \$6,716.80 from membership fees and the sale of back issues, \$149.41 forwarded by the organizers of the 2008 conference in Corvallis, and \$969.68 in funds

forwarded by the organizer of the 2010 conference in Las Cruces. Total expenses for the year were \$6,619.65, resulting in a bank balance of \$43,625.39. *SWJL* 29(2) has just been mailed out and these expenses will be reflected in the next financial report.

3. Accepted Morin's report on the Esau Award. The Award went to Jenny Dumont of New Mexico State University, who received a prize of \$400.

4. Accepted Foreman's and Cashman's report on the South Padre Island conference finances and program. To date expenses are \$18,889.86 and total income is \$18,548, for a difference of -\$341.86. Two additional registrations have been collected since the report was prepared. LASSO paid for the dinner and venue for the Executive Committee meeting, which was open to all members. UTB MAX contributed \$4401.82. Additional material support was provided by UTB and by the hotel. Approximately 95 abstracts for individual papers were received and 5 panel proposals with 14 papers. Four reviewers selected 86 papers for individual presentations and all 5 panels. There was a 17% withdrawal rate, so that the final count is 83 papers including panels, plus two special sessions by the editors of *SWJL*.

5. Accepted Jens Clegg's report on the 2012 conference to be sponsored by Indiana U-Purdue U at Fort Wayne. The conference hotel will be on campus and has guaranteed a \$90 per night rate. Jens will be program chair for the 2012 conference and his colleague, Talia Bugel, will be the local arrangements chair. The university has agreed to donate the use of all facilities at no cost. The conference will be held the second weekend in October.

7. Accepted Anderson-Mejías' report on the status of the journal. The journal did not receive the presidential address for publication. Twenty-eight manuscripts were received in 2010-2011. 2 manuscripts were returned not juried. 15 manuscripts received a positive revise and resubmit letter, 9 received a negative revise and resubmit letter, 3 were rejected after review. 15 manuscripts were resubmitted. There were 9 of 15 manuscripts accepted on resubmission. There are 8 articles in the process of being revised. There were 4 book reviews. 72 jurors reviewed articles in 2010-2011. Most of the manuscripts received were not submitted by LASSO members. The editors encouraged members to submit their work to the journal.

8. Old business: In response to our discussion regarding amending the by-laws, including looking at the language used to define our organization:

A motion was passed to propose an amendment that the word "regional" be removed from the by-laws. If passed, the word "regional" will then be removed from all print and web-based literature describing the organization and the journal.\*

A motion was passed to vote on said amendment at the business meeting of October 30, 2011.

8. New business:

Examination of the Constitution and By-laws revealed that the word "regional" does not appear in either document. Therefore, the word "regional" that appears on the home page of the LASSO website can be removed without a vote from the membership.
